



# Register of Members' Pecuniary Interests

**Summary of pecuniary interest returns

**March 2025**

Members are required under the Local Government Act 2002 (Part 4, Subpart 3 – Register of members' pecuniary interests) to make annual returns of any pecuniary interests they may hold.

This subpart also directs local authorities to keep a register of pecuniary (financial) interests of elected members and make a summary of this register publicly available.

The purpose of this summary is to record Councillor interests to provide transparency and to strengthen public trust and confidence in local government processes and decision-making.
